# Delta Zeta Housing Corp. Fishing Tournament

## ITINERARY

**Thursday, June 9, 2011** will consist of a Captain's Party & Information Session held at Tom's NFL Sports Bar 5001 NW 36 St. Miami Springs, FL 33166, at 6:30pm. At least one person from each team must attend this meeting to receive T-shirts and the rules and regulations for the tournament. The rules are subject to change at this meeting at the discretion of the tournament committee. All entry forms and fees must be submitted at the Captain's Party. Late Registrations will be assessed a \$50.00 fee, and may not receive give-a-ways.

**Saturday, June 11, 2011** "Lines in" at 7:00am and "Lines out" at 3:00pm. The weigh station will be open from 4:00 pm to 5:00 pm at Black Point Marina. 24775 SW 87 Ave Miami, FL 33032. Following the closing of the weigh-in, a dock party and awards ceremony will be held at the marina. Tournament winners will be awarded their prizes at the awards ceremony.

## RULES & REGULATIONS

### 1. REGISTRATION FEES

Entry fee is \$250 per boat/team if received on or before 5/27/11. Entry fee is \$300.00 per boat/team if received after 5/27/11. Each boat is allowed a maximum of 4 anglers. Extra anglers may be added for an additional \$50.00 each and includes extra tournament shirt and give-a-ways. There is a maximum of 6 anglers per boat. Each registered boat is eligible for general prizes.

### 2. TYPE OF TOURNAMENT

This is a Boat/Team Tournament. No changes are permitted in registered anglers after the conclusion of the Captain's Meeting. All dolphins must be entered for official weigh-in in the presence of a boat/team representative.

### 3. RULES

Unless otherwise stated, IGFA rules will apply throughout this tournament.

### 4. FISHING LICENSE

All participating anglers must possess a valid Florida Saltwater Fishing License as required by the Florida Fish and Wildlife Conservation.

### 5. CAPTAIN'S PARTY

There will be a Captain's Party on June 9, 2011, at Tom's NFL Sports Bar 5001 NW 36 St. Miami Springs, FL 33166, at 6:30pm at least one member from each boat/team must be present. All anglers are encouraged to attend. The rules of this tournament may be amended verbally or in writing at the time of the meeting. Anglers are responsible for being well informed of all rules.

### 6. ELIGIBLE FISH

All fish presented for weigh-in must be in fresh, edible condition and caught that tournament day. No mutilated fish (based on tournament committee's opinion) will be accepted. It is the angler's responsibility to maintain their catch fresh prior to the weigh-in. Minimum acceptable weight of 5 pounds is required for the entry into the tournament. All participating anglers are urged to release those fish not to be entered into the tournament. The release of fish should be in keeping with the best conservation methods to ensure continued life. Acceptability of fish will be determined by the tournament committee. Captains are required to log in their time of arrival to the dock with tournament staff. This time will be recorded as your weight-in time.

### 7. BILLFISH

Billfish are not eligible for entry into the tournament and should be released unharmed. Any angler bringing a Billfish into the weigh station shall forfeit any claim he/she may have to the tournament prize.

### 8. SCORING CATEGORY

**LARGEST DOLPHIN:** Largest dolphin weighed will win the largest dolphin prize. One dolphin per team/boat. Any dolphin entered into this category can't be entered into another category.

**AGGREGATE DOLPHIN:** Up to 4 dolphins can be weighed. The most aggregate weight will win the aggregate dolphin prize. 1 entry per boat/team.

**LARGEST FUN FISH:** will consist of Kingfish, Tuna or Wahoo. Only one of these three fish can be entered into the Largest fun fish prize. Largest fun fish weighed will win the largest fun fish prize. 1 entry per boat/team.

**FEMALE ANGLER:** Largest dolphin weighed will win the female angler prize. One dolphin per team/boat. Any dolphin entered into this category can only be entered into the aggregate dolphin category.

**JUNIOR ANGLER:** Largest dolphin weighed will win the junior angler prize. One dolphin per team/boat. Any dolphin entered into this category can only be entered into the overall category. Junior anglers must be under the age of 13 to qualify.

### 9. COMMUNICATIONS

All participating boats should be equipped with a working VHF marine radio. The tournament committee will monitor VHF channel **8**. Official times or special notifications will be announced during the tournament on this channel. **NO WEIGH-IN STATISTICS WILL BE AVAILABLE ON VHF RADIO.**

### 10. TOURNAMENT HOURS

"Lines In" at 7:00am and "Lines Out" at 3:00pm. Official times for both will be announced over VHF Channel **8**. Weigh station will close at 5:00pm on Saturday, June 11, 2011.

### 11. WEATHER CONDITIONS

In the event of unsafe weather conditions, the tournament committee may choose to postpone the tournament until a later date. Captains are ultimately responsible for their crew and should make the decision as to safe sea conditions.

### 12. BOUNDARIES

There is a 35-mile U.S. costal boundary. No Bahamian or Cuban waters.

### 13. PROTESTS

Any protest concerning the conduct of an angler or rules violations must be filed in writing with the tournament committee no later than 5:00pm on the day of the alleged violation.

### 14. PRIZES

Tournament winners will receive their prizes the day of the tournament during the awards ceremony. All prizes are based upon 21 boat entry at \$250 each.

### 15. TIES

In the event of a tie in weight, the winner will be determined by the earliest weigh-in time.

### 16. REFUNDS

**NO REFUNDS OR CREDITS WILL BE GIVEN.**

### 17: RELEASE OF LIABILITY

It is expressly understood that all participants in the Delta Zeta Housing Corporation Fishing Tournament enter at their own risk. The Delta Zeta Housing Corporation and their affiliates, sponsors, committee or any other person directly or indirectly involved with this tournament and organization shall be exempt from any liability for slander, loss, damage, negligence, harm, injury, or death suffered by any participant, entrant, fisherman, or their companions, boat captains, mates, crew may occur during the tournament or a result of the tournament. All teams are charged with a thorough understanding of applicable laws and safety rules enforced by the State of Florida and the United States of America.

### 18. SIGNING OF THE ENTRY FORM

By signing the entry form, the angler agrees to follow the stated tournament rules and regulations. Delta Zeta Housing Corporation and its sponsors may use without permission, payment or restrictions any photographs in which he or she appears for any purpose whatsoever but not limited to resale, advertising, commercial or promotional material. All anglers are required to sign their entry form as certification that they have read and agreed to abide by all rules, regulations and the above liability release. **NO ENTRY WILL BE ACCEPTED UNSIGNED.**

### 19. DISTRESS / EMERGENCY HELP

Any and all emergencies, distress or help messages should be immediately brought to the attention of the United States Coast Guard. The tournament committee is not expected, nor equipped to tow, assist or help transfer or facilitate messages or communications. It is expected of the captain of each vessel to have the necessary USCG approved life and safety equipment on board your vessel.

### 20. NO hand lines or electric reels may be used.

Otherwise there are no tackle or bait restrictions.
